Sponsorship and Collaboration Agreement

This Sponsorship and Collaboration Agreement (the "Agreement") is made and entered into by and between:

1. Purpose

The purpose of this Agreement is to establish a formal arrangement between Ayurveda Seminars & Consulting Ltd. & Consulting Ltd. and the Sponsor for the provision of Ayurveda-related seminars, workshops, and consultations ("Services") to be offered through the Sponsor's organization, community, event, or other designated platform. This collaboration aims to promote and educate participants on various aspects of Ayurveda, its principles, and its practical applications.

2. Scope of Services

Ayurveda Seminars & Consulting Ltd. shall provide the following Services as requested by the Sponsor, which may include, but are not limited to:

- **In-Person and Online Seminars:** These will cover a wide range of topics within Ayurveda, as described below, and may range in duration from one hour to eleven days:
 - Face Reading (Includes Eyes, Tongue, Ears, Nose, Throat, Neck)
 - Ashta Vidha Pariksha (Darshan, Sparshan, Akruti, Drig, Mutra, Mala, Shabda, Nadi)
 - Invisible Anatomy™ (Includes but not limited to: Chakras, Meridians, Aura, Marma, etc.)
 - Elder Care with Ayurveda
 - Ayurveda & Cancer

- Ayurveda & Mental Health
- Skin Diseases
- Sattvic Cooking Practicum
- Nadi Pariksha (Pulse Assessment)
- Multiple Sclerosis & Neuro-Muscular Diseases
- Autoimmunity in Ayurveda
- Women's Health: Menarche, Fertility, Menopause
- Sub-conscious Influence of Everyday Habits
- Introduction to Vaastu Shastra
- Importance of Seasonal Cycles
- Introduction to Chromo-Bio-Therapeutics
- Custom topics upon request

- **Individual Health Consultations:** Ayurveda Seminars & Consulting Ltd. will conduct one-on-one health consultations for individuals, based on the Sponsor's requests. Each consultation will be arranged after submission of the applicant's health history and concerns.

3. Responsibilities of the Sponsor

The Sponsor agrees to undertake the following responsibilities:

- **Logistics:** Arrange for suitable office space, resources, and office equipment to support the seminars and consultations.
- **Marketing and Enrollment:** Actively promote and market the seminars and consultations to the target audience. This includes creating and managing marketing materials and coordinating the enrollment process.
- **Client Preparation and Payment:** Prepare clients for individual health consultations and collect payments directly from the clients. The Sponsor will be responsible for paying 50% of the total consultation fee to Ayurveda Seminars & Consulting Ltd. at the conclusion of each program.
- **Event Management:** Ensure that in-person events are organized at least 6 months in advance and online events are organized at least 6 weeks in advance.
- **Travel Expenses:** The Sponsor will cover travel, accommodation, and other related expenses incurred by Ayurveda Seminars & Consulting Ltd. during in-person seminars or consultations.

4. Responsibilities of Ayurveda Seminars & Consulting Ltd. & Consulting Ltd.

Ayurveda Seminars & Consulting Ltd. agrees to:

- **Provide Educational Content:** Deliver high-quality educational content, materials, and guidance related to the topics covered in the seminars and consultations.

- **Consultation Services:** Conduct individual consultations, offering personalized Ayurveda health advice, based on the concerns and health history provided by each client.
- **Confidentiality:** Maintain the confidentiality of all client and Sponsor information, adhering to the Confidentiality Code established by Ayurveda Seminars & Consulting Ltd.

5. Compensation and Payment Terms

- **Seminars:** Income from the seminars, whether in-person or online, shall be shared 50/50 between Ayurveda Seminars & Consulting Ltd. and the Sponsor. The greater of the two amounts will apply: the 50/50 income split or Jaisri Lambert's hourly rate of \$170 CAD
- **Consultations:** The consultation fee for clients is \$170/hr. + GST for Canadian clients, and \$125 USD per hour for non-Canadian clients. The Sponsor will collect the client payments and remit 50% of the total fees to Ayurveda Seminars & Consulting Ltd. at the end of the program or consultation.

6. Confidentiality

The Sponsor agrees to respect and adhere to the confidentiality guidelines established by Ayurveda Seminars & Consulting Ltd. Both parties acknowledge that client health information, seminar materials, and other confidential data will not be disclosed to third parties without prior written consent unless required by law.

7. Termination

Either party may terminate this Agreement with written notice to the other party under the following conditions:

- **Failure to Comply:** If either party fails to comply with the terms and conditions of this Agreement, the non-breaching party may terminate the Agreement after providing written notice of the breach and a 15-day cure period.
- **Mutual Agreement:** The parties may mutually agree to terminate the Agreement in writing at any time.

8. Indemnification

The Sponsor agrees to indemnify and hold harmless Ayurveda Seminars & Consulting Ltd., its employees, and affiliates, from any claims, losses, liabilities, or expenses that may arise because of the Sponsor's actions or failure to comply with the terms of this Agreement.

9. Miscellaneous

- **Amendments:** Any amendments or modifications to this Agreement must be made in writing and signed by both parties.

- **Governing Law:** This Agreement shall be governed by the laws of the province of [Insert Province], Canada, without regard to its conflict of law principles.
- **Force Majeure:** Neither party shall be liable for failure or delay in performance due to causes beyond their control, including natural disasters, war, pandemics, or government actions.
